The owners or lessees of all registered C.Pt.H.A. stallions on or before December 31 of each year shall make written report on forms supplied by the Association showing all mares bred to said stallion during the previous year. This includes all mares owned by the owner of the stallion as well as outside mares.
3. Demand to see the registration certificate of each mare bred as this will help in the preparation of this report.
4. Be sure that the last recorded owner of the mare is the person who contracts the breeding to this stallion.
5. Give exact date(s) bred - if more than one service is given to a mare, be sure to show the different dates.
6. If pasture bred, give the date the mare was turned into the pasture and the date she was taken out of the pasture.
7. Keep a copy for your files and future use.
